


Chart 1: CROBEX[®] and equity turnover




Chart 2: Zagreb Stock Exchange bond index CROBIS[®]




Chart 3: Market Capitalization




Chart 4: Structure of equity turnover








Chart 6: Podravka d.d.






Chart 9: Institut građevinarstva Hrvatske d.d.






Chart 10: Končar Elektroindustrija d.d.
